Report of the Board of Directors

LocalTapiola Asset Management Ltd (LocalTapiola Asset Management) is part of LocalTapiolaGroup, the leading parent company of which is LocalTapiola General Mutual Insurance Company (LocalTapiola General, business ID 0211034-2). LocalTapiola General's report of the Board of Directors and financial statements are available at www.lahitapiola.fi.

LocalTapiola Asset Management in 2020

LocalTapiola Asset Management acts as the asset manager for the LocalTapiola Group companies, LocalTapiola funds and external investors. LocalTapiola Asset Management supplements LocalTapiola Group's lifelong security strategy by offering customers extensive and cost-efficient asset management solutions. In addition to institutional investors, LocalTapiola Asset Management also serves private customers. Private customers can avail themselves of LocalTapiola's award-winning mutual funds and Private Banking asset management services.

Significant events during the financial period

An SFR survey targeting institutional investors awarded LocalTapiola Asset Management as the best responsible investment asset manager for the third consecutive year. LocalTapiola was ranked the best in integrating responsibility into the investment process and in reporting.

LocalTapiola Asset Management received excellent scores for the implementation of responsible investment from the UN-supported PRI (Principles for Responsible Investment). Especially, the score improved in the area assessing active ownership practices as a result of the proxy voting services activated in spring 2019. For the fourth time, international fund analysis company Lipper awarded LocalTapiola Asset Management as the best Nordic asset manager in the small companies category. In the balanced funds category, LocalTapiola also ranked number one for the fourth time running, with all LocalTapiola's World funds (Bond World, World 20, World 50 and World 80) topping the category. Fund rating company Morningstar awarded

the LocalTapiola World 50 fund as the best balanced fund in Finland and, in addition, LocalTapiola won Morningstar's award for the best fund company in terms of the entire fund offering. The criteria for the awards is the five-year risk-adjusted income.

In autumn 2020, as a new product in our offering we launched the Star funds featuring five different risk classes, administered by LocalTapiola Alternative Investment Funds.

During the financial period, practices to prevent money laundering and terrorism have been enhanced and reporting processes improved, including transaction reporting to authorities based on discussions held with the Financial Supervisory Authority. Preparations were also made in 2020 for the sustainable finance regulation taking effect in March 2021.

Asset management services

As an investment firm, LocalTapiola Asset Management offers its customers asset management services.

The assets under management decreased by nearly one per cent to EUR 10,986.7 million (31 December 2019: EUR 11,091.2 million). The assets of the LocalTapiola mutual funds decreased to EUR 4,287.1 million (EUR 4,500.2 million).

In 2021, our objective is to further strengthen our market position in the asset management market by offering asset management concepts that meet customer needs. LocalTapiola's strategic goal is to promote savings and investment know-how among our customers while expanding the customer base for asset management services. Renewing investment service offering, together with



customers' growing interest for investing and with the need to prepare for the future through savings, provides a good opportunity to achieve this. In addition to LocalTapiola Life, in the future we will be developing cooperation with Seligson & Co, which is owned by LocalTapiola Group.

The result for 2020 shows a slight profit. Income from investment services decreased to EUR 20.6 million (1 January–31 December 2019: EUR 21.7 million). The strong market volatility brought about by the pandemic negatively affected net commissions.

Capital and reserves totalled EUR 22.6 million (31 December 2019: EUR 22.6 million). Profit for the financial period totalled EUR 0.5 million, and dividends paid in 2020 came to EUR -0.6 million.

Customers and customer benefits

LocalTapiola Asset Management serves as an independent asset manager for the LocalTapiola mutual funds. In addition, our customer base consists of institutional investors, companies, organisations and private individuals.

We offer asset management services in the form of various concepts, the most notable being

Institutional Asset Management, LocalTapiola Private Banking services and investment solutions implementing the co-investment ideology according to which he LocalTapiola Group companies invest in the same investees as our customers. The low interest-rate environment, the volatility in the investment markets, and people's preparation for the future by saving becoming more common in the time of COVID-19, have increased customers' interest in mutual fund and asset management services.

Corporate social responsibility

LocalTapiola, Asset Management adheres to Local-Tapiola Group's sustainability principles and Code of Conduct.

For us, sustainability is about

- promoting the security, well-being and success of people and communities
- promoting financial responsibility
- investing in the work community
- reducing the impact we have on the environment and climate
- risk management, and
- active participation in developing local communities and society.

Responsible investment

Our work in responsible investment continued in 2020. Early in the year, we tightened our responsible investment guidelines, especially in terms of how climate change is addressed. In the equity and corporate bond selection models, in carbon-intensive sectors we invest in companies that have the best carbon footprint. In early 2020, we tightened the limit which we use to define carbon-intensive sectors.

In addition, we introduced a new guideline, whereby in the equity and corporate bond selection models and in the factor model we avoid investing in companies which an external service provider has analysed as having the most laggard ESG classification.

We developed the sustainability assessment of fund partners and stepped up the utilisation of data from external service providers, for instance by making more extensive use of a fund analysis system, which offers in-depth information on the ESG profiles of funds and makes fund comparison easier. We require that all our fund partners are



signatories to the UN PRI principles. In our assessments, we attribute a considerable weight to our partners' PRI assessment reports, and we especially consider the score each asset manager has obtained for ESG strategy and governance. According to the reports for 2020, 84% of our fund partners received the best A+ rating in this category from the PRI. In the asset management of customer portfolios, we have made use of a more extensive offering in a range of ESG/SRI/ESG LEADERS etf funds.

LocalTapiola Asset Management as a responsible employer

LocalTapiola Asset Management also strives to operate on a responsible basis as a company. Our greatest asset are our professional and motivated personnel. We as an employer keep constantly developing responsible operations, and positive development is evident in a good working environment, spirit of cooperation and the results of the Eezy Spirit survey measuring employee well-being. More information about LocalTapiola Asset Management's actions to curb climate change is available on our website in the responsible investment report.

Corporate governance

In accordance with LocalTapiola Asset Management's active ownership principles, the key policies for active ownership are meetings with the companies' management, attending Annual and extraordinary General Meetings and influencing companies together with other investors.

In 2020, our portfolio managers met with the management of some 753 companies. Of the meetings, 431 were with companies in which our asset management customers (including the Local-Tapiola mutual funds) had invested. At the meetings, we discussed priorities central to the company's success, such as the company's strategic targets, what is required to achieve them as well as operational opportunities and challenges. At a total of 191 meetings with investees of our asset management customers, we discussed ESG issues relevant to the company's business and societal positioning, such as the environmental impacts of operations, addressing sustainable development, and the company's tax policy.

Authorised by our asset management customers (including the LocalTapiola ESG Dividend Finland fund), we attended 23 General Meetings in Finland. At 21 AGMs, we casted our votes in advance, and voted in line with the Board of Director's proposals; at two AGMs no voting took place.

A new matter discussed at the AGMs was the compensation policy, which the company must in future submit to the Annual General Meeting for advisory voting at least every four years. Compensation policies were discussed at the AGMs on a very general level, and therefore we requested from 10 companies clarification, in particular on the criteria behind the compensation policy.

Authorised by our asset management customers (including the LocalTapiola mutual funds), we attended 808 General Meetings outside Finland, in 39 countries. More information on General Meetings and voting behaviour is available on our responsible investment website and in our responsible investment annual report.

Jointly with other investors, we aimed to influence companies in engagements affecting climate change and supporting a sustainable protein production, for instance. Relating to the COVID-19 pandemic, we joined a PRI-supported initiative whereby we encourage companies to operate on a responsible and long-term basis to ensure business continuity and the security of their employees, customers and suppliers, and an initiative coordinated by our Eurapco partner, Achmea IM, to encourage pharmaceutical manufacturers to join forces to contain the virus. In addition, we are involved in a PRI-supported initiative whereby we encourage companies in the food and drink sector and in retail to commit to ensuring sufficient income for the employees in their raw materials sourcing chain.

We again took part in the CDP's non-disclosure campaign, through which we encouraged 11 of the over 600 companies on the target list towards environmental reporting. In addition, we participated in a CDP-launched SBT campaign, which strives to encourage companies to set climate science based targets to cut emissions. The campaign reaches out to some 1,900 companies.

Operating environment

Economic environment

By all indicators, 2020 was an exceptional year in the economy and in investment markets. Early in the year, the global economic outlook was still stabilising and slowly getting stronger. In February and March, the COVID-19 pandemic however forced countries around the globe to institute large-scale economic lockdown and restrictive measures, as a result of which the level of financial activity plummeted in a historic fashion.

The major economic policy interventions stabilised the situation and reassured the financial markets somewhat, and in spring economies began to recover with the lifting of restrictive measures. During summer, the speed of economic recovery was more rapid than what was feared. Even though the speed of the recovery slowed down late in the year, the global economic outlook remains fundamentally positive: The economy will recover in 2021, but the start of the year is challenging due to the COVID-19 situation. In the latter half of the year, economic growth may rebound even considerably.

Economic recovery is also expected to continue in the eurozone, when the COVID-19 situation will be contained gradually. With a deterioration in the COVID-19 situation, the eurozone economy is expected to have contracted again late in the year. The COVID-19 situation will also exert a negative influence in the eurozone early in the year. However, the economic impacts of the restrictive measures taken are expected to remain more moderate than last spring. It appears that Finland will survive even the newest wave of infections with less damage than many other European countries.

Investment market development experienced constant ups and downs in 2020. In March share prices plummeted and uncertainty in the stock markets soared to a historic high. Conversely, market rebound was exceptionally strong. This development was underpinned by the massive aid and stimulus packages by countries and exceptional central bank aid, which are also expected to support the economy and the investment markets in future.

In bonds, corporate bonds and developing interest rate markets, price movements were also steep during the year. Extraordinary price movements

were experienced not only in equities and fixed-income investments but also in raw material prices and foreign exchange rates. In the exchange market, the euro gained on the dollar and on emerging market currencies during the year. With the foreign exchange rate movements that took place, of all fixed-income investments eurozone bonds offered the best yield for European investors.

Solvency and risk management

Solvency management

The solvency management process at LocalTapiola Asset Management is composed of CCR/CRD regulation compliant Pillar I solvency calculation and reporting and the company's own economic capital calculation model (ICAAP), which strengthens Pillar I calculation, taking into consideration the dimensions and risks not covered by Pillar I calculation. These include risks associated with the operating environment and changes in it. The analysis also incorporates the results of the annual risk identification. The Board of Directors determines the guidelines for the company's risk appetite in annual planning by setting the target levels for the relations between the capital requirements and own funds as well as for the quality of own funds. Solvency calculation takes place and the results are reported to the Board of Directors on a quarterly or as-needed basis.

At the close of 2020, the company's solvency ratio was 44.3 per cent (46.4%), and the solvency position is thus excellent. The result for 2020 was confirmed only after solvency calculation, which is why it is not included in Common Equity Tier 1 Capital. Considering this, solvency would have been 45.5 per cent (49%).

Risk management

Risk management at LocalTapiola Asset Management is based on current legislation and the regulations and guidelines issued on it. The company's operations adhere to LocalTapiola Group's risk and solvency management principles, and the company's risk management process is part of the Group's risk management process.

In the risk management plan approved annually, the company's Board of Directors defines the targets and limits of risk-taking, and it is responsible for organising risk management, regularly monitors the level and development of risk-taking and decides on the risk management measures needed, where appropriate. On an annual basis, LocalTapiola Group's risk management function submits to the Board of Directors a statement on the implementation of the risk management plan.

Executive management is responsible for day-to-day risk management and the development of the risk management process together with Local-Tapiola Group's risk management function. Internal audit supports the management and the Board of Directors in developing monitoring and risk management.

The risk management process includes risk identification carried out in connection with annual planning, which assesses the strategic, operative and legal risks and those related to the operating environment which the company may face. The risks assessed to have operational relevance are recorded in the risk management plan, and risk management measures are defined for them.

No material changes from the previous year have taken place in the risk management principles.

Risk management in more detail

The notes to the financial statements describe in more detail the organisation of risk management, monitoring of the various risk classes, and risk levels.

Corporate governance, personnel and remuneration

LocalTapiola Group's corporate governance and management system

LocalTapiola Group and the Group companies adhere to good corporate governance, which is based on legislation applicable to the insurance and finance sector, the regulations and guidelines issued by the Financial Supervisory Authority and, where applicable to mutual insurance companies, the Finnish Corporate Governance Code for listed companies.

LocalTapiola Group forms an insurance group referred to in the Insurance Companies Act, and LocalTapiola General is the group's leading parent company as specified in said Act. In this role, LocalTapiola General is responsible for reliable management, solvency monitoring, risk management, internal control and organisation of related regulatory reporting within the entire LocalTapiola Group and all Group companies.

The LocalTapiola Group companies have concluded intra-Group agreements on their mutual responsibilities and division of duties. LocalTapiola Group's Management Group, appointed by LocalTapiola General's Board of Directors, has broad representation from the various LocalTapiola Group companies and from the most important shared functions.

The Group's Management Group is responsible for the preparation of LocalTapiola Group's strategic and other Group-level matters, related decision-making and implementation, as well as for the overall control and development of the Group, within the authorisations granted to it by the Board of Directors that are in line with the joint agreement signed by and between the LocalTapiola Group companies.

As a subsidiary of LocalTapiola General, LocalTapiola Asset Management adheres to LocalTapiola



Group's shared corporate governance and management procedures.

Annual General Meeting

LocalTapiola Asset Management Ltd's Annual General Meeting was held on 23 March 2020. The meeting approved the financial statements for 2019, decided on the use of the company's profit, discharged the members of the Board of Directors and the Managing Director from liability, and elected the company's auditor. The meeting also confirmed the number of the members of the Board of Directors and their remuneration. The Extraordinary General Meeting on 23 April 2020 confirmed the composition of the Board of Directors.

The General Meeting confirmed the profit distribution proposal by the Board of Directors on the dividend to be paid in 2020.

Board of Directors

LocalTapiola Asset Management Ltd's Board of Directors comprises eight members, with a term of one year. The Board members shall have wideranging and complementary professional expertise and experience as well as the skills in the business operations of an investment company that are necessary taking the quality and scope of the company's operations into consideration.

It monitors and assesses the financial position, the management, supervision and risk management systems, operating prerequisites and changes in the operating environment of the companies it supervises.

Remuneration

The aim of the special remuneration scheme is to incentivise good performance and to boost the motivation and commitment of personnel. LocalTapiola Asset Management's remuneration policy is

based on the strategy of the Group and its companies, and the targets set on the basis of the strategy.

Remuneration is based on the person's good work performance in relation to the targets set. The bonus scheme is part of the remuneration package, and it is based on annual bonuses, although some bonus targets may measure periods that are longer than one year. The special remuneration scheme covers senior managers and all personnel.

When confirming the special remuneration scheme, the company strives to ensure that the scheme is in line with the business strategies, objectives and values of the company and of Local-Tapiola Group as a whole, that it works in the Group's long-term interests, that it is compatible with the Group's principles of good and effective risk management, and that it does not encourage excessive risk-taking.

Events after the financial period

A company belonging to LocalTapiola Group purchased the shares of the main owners of Seligson & Co Fund Management Ltd in 2020. The Group's objective is the centralised management of the funds business.

Future prospects

Asset management activities

The challenges faced by the investment markets and by the economic outlook will, with the prolonged pandemic, continue in 2021. Market development has a significant impact on the company's financial performance.

We are actively involved in LocalTapiola Group's lifelong security strategy by making asset management services available to small investors better than thus far. The Group is in the process of renewing its strategy during 2021, and LocalTapiola Asset Management participates closely in planning in the Finance, savings and investment sub-area.

The role which responsibility plays in our customer's investment activities and in the demand for investment services is growing further, and we are developing products to meet this need. Additionally, we want to maintain our competitive edge in the world of low yields and ever-fiercer price competition.



Investment activities

With decreased interest rate levels, the outlook of fixed-income investments for the current year is more challenging than before. The outlook for the stock market is somewhat two-sided. The economic outlook, which is strengthening with COVID-19 vaccinations, the major economic policy interventions, zero interest rates and investors' search for yield still support risk-taking. On the other hand, several uncertainty factors remain, and the valuation levels of shares have increased. Share market pricing must be geared to the prevailing interest rate environment, so the question of valuation levels ultimately also returns to the relative valuation of asset classes.

In the short term, investors' attention focuses on economic recovery, recovery measures and COVID-19 vaccinations. For these, time will tell whether development will conform to market expectations or not. Later we will face the economic adjustment measures and other long-term questions. Factors behind political and geopolitical uncertainty may also cause price swings. The situation underlines the long cycle and risk management of investment activities.

Proposal on measures concerning profit and unrestricted equity

Proposal by the Board of Directors to the Annual General Meeting

Distributable assets in the financial statements total 19,971,622.14, of which the profit for the financial period is 548,484.90. There have been no material changes in the company's financial position after the end of the financial period, and neither does the solvency test referred to in Chapter 13(2) of the Limited Liability Companies Act have a bearing on the amount of distributable assets. However, the company's operations face factors of uncertainty caused by the COVID-19 pandemic and by a business transformation, which must be addressed when making a decision on the distribution of any dividend.

The Board of Directors proposes to the General Meeting to be held on 9 April 2021 that, from the profit for the 2020 financial period, no dividend be paid on either share series (not on A series or B series) but that the profit for the financial period, EUR 548,484.90, be transferred in full to the profit and loss account of previous financial periods.

Accounting principles

LocalTapiola Asset Management Ltd's financial statements and report of the Board of Directors have been prepared in accordance with the Finnish Accounting Act and Decree; the Act on Investment Services; the Act on Credit Institutions; the Ministry of Finance's decree on the financial statements, consolidated financial statements and report of the Board of Directors of credit institutions and investment firms; the regulations and instructions of the Financial Supervisory Authority; and the general guidelines of the Accounting Board.

General information

LocalTapiola Asset Management Ltd is owned by LocalTapiola General Mutual Insurance Company, LocalTapiola Mutual Life Insurance Company and the regional non-life insurance companies part of LocalTapiola Group.

LocalTapiola Asset Management Ltd's (business ID 1604393-7) domicile is Espoo and its address is Revontulenkuja 1, 02100 Espoo, Finland. The financial statements are available at www.lahitapiola.fi.

The Board of Directors approved the financial statements for 1 January–31 December 2020 in its meeting on 3 March 2021.

Summary of key accounting principles

The receivables from credit institutions item includes deposits made with credit institutions. Receivables to be repaid no later than within one day of cancellation are considered receivables payable on demand. Negotiable receivables from credit institutions are not recognised in the balance sheet item.

Debt securities comprise all marketable debt instruments, such as treasury bills, local government papers, bonds issued by governments and other public entities, banks' certificates of deposits, commercial papers as well as bonds and convertible bonds issued by banks and companies. Debt securities are classified for valuation as measured at amortised cost.

Shares and holdings are individually classified for valuation as financial assets at fair value. Subsequent valuation is achieved at cost, if the fair value cannot be determined reliably (Tier 3).

Investments in subsidiaries and investments in associated and joint undertakings are measured at amortised cost.

In **intangible assets**, the design expenses of IT systems acquired for value and the costs of renovations in apartments have been activated as other long-term expenditure. They are amortised over 10 years from commissioning or a shorter economic period of utilisation.

The **other tangible assets** balance sheet item comprises equipment, presented in the balance sheet at cost less planned amortisation and depreciation. The annual amortisation rate of equipment is 25% of net expenditure.

Under **net commissions**, commissions are recognised when the service or separate measure has been carried out. The amount of net commissions is the fair value of the consideration received.

Interest income shows the interest income derived from the balance sheet items included in the "Receivables from credit institutions" assets. Negative interest rates are shown in interest expenses.

Other operating expenses shows rental expenses as well as the control, inspection and membership fees of authorities.

Changes in accounting principles affecting the comparability of the result for the financial period with the result for the previous financial period

No material changes have taken place in the accounting principles.

Notes on solvency management and risk management

LocalTapiola Asset Management's solvency management process is based on current European Union and national legislation and the guidelines, regulations and standards issued on it.

LocalTapiola Asset Management's risk management is based on current legislation, on the regulations, guidelines and interpretations issued on it, and on LocalTapiola Group's risk management policy and practices. The company's risk management process is part of the group's Own Risk and Solvency Assessment (ORSA).

Publication of solvency data

The solvency data described in the Act on Credit Institutions and in the Financial Supervisory Authority's regulations are included in the company's report of the Board of Directors.



Rationale for risk management

Risk management refers to active and proactive activities that aim to identify, assess, limit, utilise and monitor business threats and new opportunities arising from changing external and internal conditions or LocalTapiola's own strategic intent. The aim is to promote the continuity of customers' financial security and support the reaching of the Group's operational and financial targets. In accordance with the principles of corporate responsibility, the Group manages its risks and provides reliable information on risks and risk management to customers and other stakeholders.

The key areas of risk management and the risk categories are:

Financial risks

- Risks relating to solvency management
- Market risks
- Credit risks
- Liquidity risks
- Concentration risks

Operational risks

- Risks relating to business planning
- Process risks
- Systemic risks
- Personnel risks
- Legal risks
- Risks of damage

Risks associated with the operating environment and strategy

- Risks associated with the general operating environment
- Risks associated with changes in the markets and customer behaviour
- Risks caused by the nature of competition and by competitors
- Risks related to strategic choices
- Group-level special risks

Organisation of risk management

The company's Board of Directors has the overall responsibility for organising risk management. The Board defines the risk management targets, risk appetite, limits of risk-taking, responsibilities, metrics and monitoring principles. The Board annually confirms the plans that discuss risk management, ensures that they are taken into account in the operational plans and monitors the implementation of and compliance with these plans. On a regular basis, the Board also monitors the status of risk management and the development of key risks.

The Managing Director and senior management are responsible for the practical preparation and

implementation of risk management and for monitoring implementation. The business units are responsible for identifying risks related to their own operations and taking the related risk management measures required. The supervisors are to ensure that the control of operational processes is adequate and that there is always reliable and up-to-date information available on the results of the control. All employees have an obligation to report on any risks observed or areas for improvement identified in risk management.

LocalTapiola Group's risk management function supports the maintenance and development of the risk management process and is in charge of the company's solvency management process and solvency calculation.

The company's legal function ensures that the company's operations adhere to all laws, official regulations and internal guidelines. The supervisors are in charge of internal control for their own subordinates, also covering operational compliance. The Compliance Officer submits to the Board of Directors a report on the observations he or she has made each year.

Internal audit assists the Board of Directors and the management in the practical implementation of risk management control and risk monitoring. The auditing function also supervises the implementation of risk management.

Risk identification, measurement and management

The identification of operational risks and of those caused to the operating environment, their probability and impacts are evaluated at the business units during annual planning and whenever there is a significant change in the risk position. A separate risk management plan is prepared for every risk that requires active management. The results of risk identifications are included in the company's solvency management process.
